



Notice is hereby given that the Board of Directors of Kleinwood Municipal Utility District will hold a regular meeting, open to the public, on **THURSDAY, 24 MARCH 2022, at 6:00 p.m.** at the District Office, **16530 Kleinwood Drive, Houston, Texas**, within the boundaries of the District. **Guests attending the meeting via teleconference, please dial 877-746-4263 and enter Guest Code 2925180.** The Board will consider and act upon the following matters:

1. Consider comments and questions from District residents (3-minute limit);
2. Minutes of the Board of Directors meeting of 24 February 2022;

5. Report on maintenance of stormwater detention facilities;

 - (a) authorize payments from the District's Tax Account;

 - (c) discuss and approve the annual payments to Cypress Forest PUD and HCMUD 24 pursuant to the 1982 and 1987 Water Supply and Waste Disposal Contracts;

 - (b) report on inspection of sanitary sewer lift stations;
 - (c) review 10-year Capital Improvement Plan;

 - (e) discuss requests for service and authorize actions deemed necessary;
