



Notice is hereby given that the Board of Directors of Kleinwood Municipal Utility District will hold a regular meeting, open to the public, on **THURSDAY, 22 SEPTEMBER 2022, at 6:00 p.m.** at the District Office, **16530 Kleinwood Drive, Spring, Texas**, within the boundaries of the District. **Guests attending the meeting via teleconference, please dial 877-746-4263 and enter Guest Code 2925180.** The Board will consider and act upon the following matters:

1. Consider comments and questions from District residents (3-minute limit);
2. Minutes of the Board of Directors meeting of 25 August 2022;
3. Security Report (Harris County Precinct 4 Constable's Office);
4. Financial Advisor's Report, including:
 - (a) consider tax rate recommendation from the District's Financial Advisor;
 - (b) schedule hearing on proposed 2022 tax rate and authorize publication of notice of hearing
5. Report on maintenance of stormwater detention facilities;
6. Tax Assessor/Collector's Report, including:
 - (a) authorize payments from the District's Tax Account;
 - (b) status report regarding delinquent tax accounts;
7. Engineer's Report, including:
 - (a) status of contract for Phase II of Sanitary Sewer Rehabilitation project (Insituform Technologies, LLC);
 - (b) status of design for proposed electrical improvements to Lift Station No. 2;
 - (c) status of Capital Improvement Plan;
 - (d) status of private water well (The Falls at Champion Forest);
 - (e) discuss requests for service and authorize actions deemed necessary;
8. Attorney's Report, including:
 - (a) review report regarding arbitrage rebate calculations (Series 2011 Refunding Bonds, final computation period) and authorize actions deemed necessary;
 - (b) discuss rescheduling 11/24/22 & 12/22/22 Board meetings, as needed (Thanksgiving and Christmas holidays);
 - (c) approve adjustments to engineering rate schedule (formal approval);
 - (d) status of groundwater credit certificates;
 - (e) matters relating to North Harris County Regional Water Authority;
 - (f) discuss power supply issues (P3 and Cavallo Energy);
 - (g) status of filing continuing disclosure for the District (due 9/30/22);
